Dear Ms. Padmini Ji,

I am happy to inform you that the Expert Committee constituted by the Ministry of Culture, Government of India based on the proposal submitted by you has selected you for award of **Senior Fellowship for 2014-2015** in the field of Dance & Dance Music Sub-Field Bharatnatyam for a period of two years with effect from 01-07-2017. The value of the Fellowship will be **Rs. 20,000/- per month** and the same will be released in 4 six-monthly instalments as per present provisions.

The Centre for Cultural Resources and Training (CCRT) will require a six-monthly Progress Report as per the schedule overleaf. The first and the second instalments of Fellowship will be released on the receipt of 1<sup>st</sup> and 2<sup>nd</sup> six monthly Progress Report, respectively. The third instalment will be released after review of progress of your 1<sup>st</sup> and 2<sup>nd</sup> six-monthly reports by an Expert Committee and after the receipt of your 3<sup>rd</sup> six-monthly progress report. On completion of the Project, one bound copy of 2 years' complete Project document will have to be submitted to CCRT. The fourth instalment will be released after the 4<sup>th</sup> six-monthly progress report and the bounded copy of the complete Project document are received and evaluated by the designated Expert Committee. The last date for submission of the complete Project Report is **June 30, 2019**. However, in exceptional circumstances extension of time by maximum three months will be permissible without any additional financial liability to the Government of India/MoC/CCRT.

The six-monthly research reports should contain details of the work done by you during the relevant period of six months, and in addition it should also contain evidence of your work, which may be in the form of Photographs, Press Reviews, Survey work, etc.

It may please be noted that the Government of India/Ministry of Culture reserves the right to discontinue the grant of the Fellowship at any time if and when after review/enquiries, etc. Ministry of Culture comes to the conclusion that you have either abandoned the Project work or are not pursuing this work seriously.

You are also required to send the **proof of leave** from your organization if you are regularly working in a Government /State Department/University/Establishment/Institute, etc. The Fellowship is liable to be cancelled in case the **proof of leave** is not sent.

In case you are getting pension from this Ministry under the Scheme of "Financial Assistance to Artistes in Indigent Circumstances", you will have to opt for either of two: grant of Pension or grant of Fellowship.

Madam,

I am happy to inform you that you are among the teachers selected for Associateship of the U.G.C. Inter-University Centre for Humanities and Social Sciences (IUC), functioning at the Indian Institute of Advanced Study, Shimla.

2. The academic session of the Centre commences on the **1<sup>st</sup> March, and continues up to the 30<sup>th</sup> November each year.**

3. (i). For taking up the Associateship, the Centre defrays the expenses on travel [Travelling allowance is limited to AC-II tier sleeper class], between the place of work and Shimla (to and fro) as per Government of India norms.

(ii). The Centre pays a Maintenance Allowance @ Rs.400/- per day. A sum of Rs.200/- per day will be deducted directly as accommodation/Mess Charges (For serving Breakfast, Lunch and Dinner except official dinners) from the maintenance Allowance being paid at the end of each spell of Associateship. The local scholars who do not avail accommodation at the IUC Guest House of the Institute, a sum of Rs.100/- per day will be deducted directly as Mess Charges (Breakfast and Lunch) from the maintenance Allowance at the end of each spell of Associateship.

(iii). The residential accommodation provided by the Institute is for self only (and **not for family**).

4. The Associates are allowed to make use of the library of the Indian Institute of Advanced Study, and are expected to participate in all the ongoing academic programmes of the Institute.



## Kingston-REVA Joint Research Project Indian MSMEs' responses to the Covid-19 pandemic crisis



(A Joint Research Project funded by HEFCE Global Challenge Research Fund, United Kingdom)

### ABOUT THE PROJECT

This is a joint project between Kingston University, London (UK) and REVA University, Bengaluru (India), which is funded by HEFCE Global Challenges Research Fund (GCRF) 2019-20 allocation for Kingston University. The project investigates the multi-disciplinary challenges facing Indian Micro, Small and Medium Enterprise (MSME) businesses focusing generally on business strategy in an economic downturn and particularly on coping mechanisms and innovative behavior in the light of the economic crisis due to the Covid-19 pandemic.

The project aims to build capacity through the cooperation of Kingston and REVA universities and with business managers, entrepreneurs, and policy makers in India. The approach used in the project is for generating pathways to impact focusing on three user groups: entrepreneurs, membership associates for businesses and policy makers. The key highlights of the project are summarized in the box below:
