**GRADUATE PROGRAM AGREEMENT  
BETWEEN  
THE UNIVERSITY OF ALABAMA IN HUNTSVILLE  
AND  
REVA UNIVERSITY**

THIS AGREEMENT is made between The Board of Trustees of the University of Alabama, a public educational and constitutional instrumentality of the State of Alabama, incorporated by statute, for and on behalf of the University of Alabama in Huntsville, 301 Sparkman Drive, Huntsville, Alabama, USA (herein, "UAH"), and REVA University in India.

1. Degree Plan: In year one, students are to take four 3-credit hour graduate courses required for the UAH Master of Science in Computer Science or Cybersecurity or Software Engineering degree, among others (e.g., prerequisite courses and ILC courses as described in curriculum), via REVA in India and transfer the four 3-credit hour graduate courses to UAH. In year two, following the award of their undergraduate degree by REVA, the students are to take at least six more 3-credit hour required graduate courses at UAH in the US. Upon satisfactory completion (see definition in curriculum), the students will be awarded the MS-Computer Science, the MS-Cybersecurity, or the MS-Software Engineering degree by UAH.
2. Criteria: Attachment I outlines admission requirements including Grade Point Average (GPA), TOEFL or IELTS scores, and other relevant issues. All students meeting the criteria will be admitted.
3. Curriculum: Attachment II lists Curriculum Requirements for this collaborative MS-Computer Science, MS-Cybersecurity, and MS-Software Engineering programs. For all the courses taken via REVA in year one, REVA will administer exams offline and provide students' transcripts to UAH.
4. Cost of studies: While in India (year 1), students pay tuition to REVA for the courses taken via REVA, except for the two ILC seminar courses for which students pay tuition to UAH at tuition rate for that year, currently at \$250 per credit hour. While at UAH (year 2), the cost of study will be determined by the tuition, fees, and other costs for study at UAH applicable at the time students enroll at UAH. As an example, Attachment III lists the 2018-2019 tuition and other costs, including course fees, facilities fee, international student fee, typical residence hall rates, meal plan, books, supplies, etc. In general, when tuition increases are made, the increase is typically less than 10% per year. Tuition rates and fees are determined by The Board of Trustees of The University of Alabama and are subject to change during the term of this Agreement. Tuition, fees, and all other costs for study will be paid by students directly to REVA or to UAH, as applicable. In no event will funds be exchanged between REVA and UAH.
5. Fellowship Scholarship: When students are admitted to the graduate school at UAH and are full-time, those with exceptional GRE scores and GPAs are automatically considered for a

Graduate Student Fellowship Scholarship. No scholarship application is required. Attachment IV lists the scholarship matrix.

6. **Student Rights and Responsibilities:** Program students will be treated the same, enjoy the same rights, and share the same responsibilities as other UAH students. Once admitted, students will be provided a UAH student account and will be able to access the UAH library via the Internet starting year one. All students at UAH shall abide by the U.S. laws and regulations, state of Alabama laws, and UAH policies.
7. **Eligible Students:** Only foreign-born students residing in foreign countries who are not eligible to receive Federal (U.S. government) student assistance at UAH shall be eligible for participation in this Program as provided for this Agreement.
8. **Term:** This Agreement shall become effective upon execution by both parties. It shall continue in effect for a period of five years from the most recent execution date below, unless either party acts to terminate as provided below.
9. **Termination:** Either party may at any time, with or without cause, terminate this Agreement without cost or penalty by giving the other party ninety (90) days written notice of such termination. In all cases, however, both parties are obligated to honor all commitments associated with students admitted and registered under this Agreement, and subsequent agreements, appendices, and subsequent modifications, to allow timely completion of all requirements for the degrees of those students. The “degree” refers to the degree for which the student has been admitted and registered.
10. **Entire Understanding:** This document constitutes the entire agreement between the parties, and all prior discussions, agreements, and understandings, whether verbal or written, are hereby replaced by this Agreement.
11. **Modifications:** Any changes, modifications, or amendments to this Agreement must be reduced to and approved in writing by both parties.







## ATTACHMENT I

### ADMISSION CRITERIA

Students will be considered admissible to the collaborative MS programs listed above if they meet the following requirements:

1. Bachelor degree students of Computer Science who have completed at least 3 years of coursework at REVA University in India can apply.
2. An application form must be completed. The form can be downloaded from UAH website: ([https://www.uah.edu/images/colleges/graduate-studies/forms/Application\\_grad\\_degree\\_062017\\_4c.pdf](https://www.uah.edu/images/colleges/graduate-studies/forms/Application_grad_degree_062017_4c.pdf)).
3. An application fee, \$60, must accompany the application along with the appropriate test scores and transcripts.
4. Minimum overall college GPA 3.25 (on 4.0 scale) in undergraduate studies.
5. English proficiency:  
TOEFL (iBT): all sub-scores  $\geq 18$  OR  
IELTS: all sub-scores  $\geq 6.0$
6. For the first year, student applications with the above information items 1-5 must be received by UAH by **June 15**. UAH will make decisions and provide admission letters within 30 days.
7. For the second year, submit minimum GRE of 300.
8. For the second year, students must have completed Bachelor degree before enrolling at UAH.
9. For the second year, an Affidavit of Financial Support (downloadable from UAH website [https://www.uah.edu/images/colleges/graduate-studies/forms/AAA\\_Affidavit\\_of\\_support\\_2017-2018.pdf](https://www.uah.edu/images/colleges/graduate-studies/forms/AAA_Affidavit_of_support_2017-2018.pdf) with appropriate bank document must be submitted before an I-20 Form is issued.
10. For the second year, student information in items 7 & 9 must be received by UAH by **May 15** to assure timely visa application. Students are to arrive at UAH in early August.

For all the courses taken via REVA in year one, REVA will administer exams offline and provide students' transcripts to UAH.

In year two, students are required to take at least six more 3-credit hour graduate courses at UAH for MS-Cybersecurity and MS-Software Engineering, and at least seven more 3-credit hour graduate courses for MS-Computer Science Degree.

The degree requirements may be amended in the future, with the consent of REVA and UAH, to remain current with changing technology.

**REQUIREMENTS FOR FELLOWSHIP PARTICIPATION**

1. The matrix represents fellowship as a percentage of tuition. Tuition is defined as the cost per credit hour of enrollment and does not include academic fees.
2. They must be first time/fulltime on campus students to begin participation
  - a. For a Master's degree they receive the fellowship for 2 years (4 semesters)
  - b. For a PhD degree they receive the fellowship for 4 years (8 semesters)
  - c. If a student receives GTA, GRA, or GA funding then the fellowship will no longer be valid
3. To be eligible for the fellowship the student must take an entrance exam (GRE/GMAT/MAT).
4. The undergraduate GPA is determined by the transcript(s) sent to UAH. All transcripts are used to calculate the undergraduate GPA. A single value will be computed and used for fellowship placement purposes.
5. The GRE/GMAT/MAT score submitted to UAH at the time of application will be the one used for fellowship placement purposes. If a student has taken the exam more than once then the highest score for a complete exam will be used. We do not use or combine partial exam scores.
6. The fellowship applies to students in a degree-seeking program.
7. Students must be fulltime and enrolled each fall and spring semester.
8. In order to continue their fellowship students must maintain a 3.0 GPA and be in good academic standing.
9. Combined scholarship cannot exceed cost of tuition.
10. Online students are not eligible.

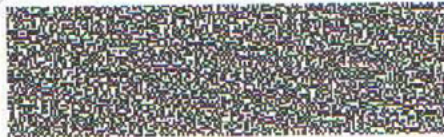
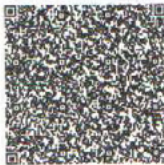

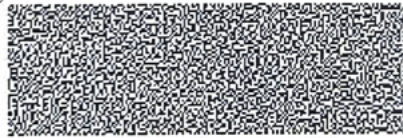

This Memorandum of Understanding (hereinafter referred to as MoU) is made on this 29<sup>th</sup> day of the month of July in the year 2020 by and between the **ICAR National Institute of Veterinary Epidemiology and Disease Informatics (ICAR-NIVEDI), Bengaluru-560064, Karnataka, India** (Name of the ICAR Institute) having its Head Office at **Bengaluru-560064, Karnataka, India** [herein after called "**ICAR-NIVEDI**"/First party], a constituent Research Institution of the Indian Council of Agricultural Research, Krishi Bhavan, New Delhi-110 001 on the ONE PART and the **REVA University, Rukmini Knowledge Park, Kattigenahalli, Yelahanka, Bangalore-560064, Karnataka, India** [Name of the AU/ICAR DU (Within NARS) or Central/State Govt./Public Sector Funded Institution/State University/Autonomous Body/Private University or Institution] having its headquarters at **Bangalore-560064, Karnataka, India** [hereinafter called "**REVA University**"/Second party] on the OTHER PART (who for the purpose of this MoU are hereinafter collectively referred to as the parties)

The parties, having discussed fields of common research interests and allied activities between the two institutions, have decided to enter into long term collaboration for promotion of students' training and quality postgraduate research in cutting edge areas in accordance with the provisions contained in the Guidelines issued vide Letter No. 2 8/2012-HRD dated 11<sup>th</sup> December, 2012 or as revised from time to time.



WHEREAS the "First Party" is involved in the studies on **Veterinary epidemiology and disease informatics** (specific mandated domain within the approved disciplines/divisions)

AND WHEREAS the "Second Party", established vide F. No dated 7<sup>th</sup> February 2013 by Govt. of India/Govt. of Karnataka (Name of the Agency) vide Act No2012 as a Private University and notified Karnataka State Gazette notification No.80 SAMVYASHAE SHASANA 2012 and has been recognized as per section 2(A) (of University Grants Commission) is involved in Graduate, Postgraduate Education and Research (specific areas of research),

AND WHEREAS it has been considered expedient to agree in writing to participate jointly in the projects requiring expertise and logistics from both the parties.

**Article 1. Scope**

- 1.1 The Second party will recognize the First party as an Institute for conducting research related to the thesis requirement of the research students for PG/PhD(Name of the degree programme). The Second party will recognize Scientists of the ICAR Institute as recommended by its Director in accordance with the University rules and regulations for guiding students working for the said degree.
  - 1.2 Operational details of research effort and collaboration will be made in common research programmes and/or projects restricted to specific mandated domain within the approved disciplines/divisions. The objective(s) for research work for a student coming from a Second party outside NARS should be exclusively different as far as possible.
  - 1.3 Research instrumentation facility and library facilities available with the First party and the Second party will be made available to the faculty and research scholars. However, the costs of specific consumables will be borne by the respective organizations.
  - 1.4 There shall be an exchange of students for academic, research and training purposes.

Accommodation in the Hostel shall be arranged, wherever possible, as per extant rates. The duration of exchange visits will be determined by mutual consent between both the parties.

#### Article2. Management

- 2.1 Director of the First party and the Vice-Chancellor/Head of the Institution of the Second party will be responsible to work out operational details of co-operation between the two organizations and ensure proper and effective implementation of this MoU.
- 2.2 The Advisory Committee will meet at least once in a year alternatively in the institutions of the First party and the Second party to review the activities. This meeting shall include presentation on the academic and research activities, which should be open to the students, faculty and scientists.

#### Article3. Exchange of Information

- 3.1. The term "information" includes scientific or technical data, results and/or methods of investigation, and other information intended to be provided, exchanged, or arising under project descriptions entered into pursuant to this MoU.
- 3.2. The parties support the widest possible dissemination of information. Each party in joint projects shall be given the right to use, disclose, publish or disseminate such information for any and all purposes.

#### Article4. General Provisions


- 4.1 It is understood that the First party and the Second party subscribe to the principle of equal opportunity and do not discriminate on the basis of race, sex, age, caste or religion. Both the Institutions shall abide by these principles in the administration of this agreement and neither party shall impose criteria for exchange of scholars or students, which violate principles of non-discrimination.
- 4.2 Both parties understand that all financial agreements will have to be negotiated separately and will depend on the availability of funds.
- 4.3 Both parties acknowledge that exchange of students from one party to the other shall be subject to the availability of funds and shall comply with the regulations and policies of the First party and the Second party.
- 4.4 Any research publications arising will be jointly published in accordance with the provisions laid out in Item 3.2.1C of the Guidelines for the students to conduct research for their degree programme as trainees at ICAR institutions as notified vide Letter No. 2- 8/2012-HRD dated 11<sup>th</sup> December, 2012 or revised guidelines, if any, as may be issued from time to time.

- 6.2 Admission of the students and the award of degrees for different programmes will be the responsibility of the Second party as per the rules and regulations.
- 6.3 Allotment of the students at the First party will be done by the approval of Director of the First party and Vice-Chancellor/Head of the Institution of the Second party.
- 6.4 The First party would have the right to screen the student's eligibility for admission based on their academic period.
- 6.5 The PME Cell of the First party in consultation with the representative of the Second party shall decide the location and sharing quantum of research work.
- 6.6 The number of student(s) at any particular time will be subjected to the availability of research facilities and scientists' time to guide thesis research at the First party institution.
- 6.7 Any student(s) admitted to the First party for training/postgraduate research, if found violating the rules and regulations laid down by the First party or indulge in such activities that amount to tarnishing the image of the Institute, or cause damage to the property, the registration of such student(s) would be summarily terminated. The Second party will not complete the formalities of issuing the certificates to such students until they compensate the losses to the First party.
- 6.8 Fees will be charged from the students by the First party as per Guidelines for the students to conduct research for their degree programmes as trainees at ICAR institutions vide Letter No. 2-8/2012-HRD dated 11<sup>th</sup> December, 2012 or revised Guidelines, if any, as may be issued from time to time. No fee may be charged by the First party from the students registered with AU/DU within NARS. However a student registered with a Second party, outside NARS, will deposit fee of Rs. 10,000/- for training duration of 3 months (not leading to a degree/dissertation) and Rs. 30,000/- per semester (six months) for training, research, dissertation exceeding three months. Any change in fee structure by ICAR will be applicable from the date of revision and shall be charged by the First party.


#### Article 7. Entry into effect, modification and termination

5. Intellectual Property Rights (IPRs): The authority to protect the expected IPRs generated or likely to be generated during research work shall rest with the institution where the major part of the research work was carried out. In the event of equal amount of work being carried out at both the Institutions of First Party and Second party, patents/protections/Knowledge generated will be shared in proportions as per the ICAR Guidelines for Intellectual Property Management and Technology Transfer/ Commercialization' as amended from time to time. All the microbial cultures/isolates confirmed during the course of study will be considered as a part of First Party's microbial repository.
6. The total number of students per scientist in First Party's Institution will be decided by the competent authority of the First party.
7. The total number of students in First Party's Institution will be decided by the competent authority of the First party.

## 2 General Terms

### 2.1 Intellectual Property Rights

- 2.1.1 For the purposes of this Clause 2.1, "Material" shall mean the materials, in whatever form, used by CG to provide the Services and the products, systems, programmes or processes, in whatever form, produced by CG pursuant to this MoU.
- 2.1.2 Any and all "Material" used in connection with programme delivery, including but not limited to intellectual property rights such as training curriculum, laboratory work, technical information, know-how, patent application right, patent right, copyright and trade secrets, etc. (the "IP Rights") shall be exclusively owned by CG.
- 2.1.3 REVA shall not use, copy, amend or distribute the "Material" in any form to internal and external parties.

### 2.2 Terms for Termination

- 2.2.1 This MoU shall be effective on the date hereof and shall continue, unless terminated sooner in accordance with Clause 2.2
- 2.2.2 Either Party may terminate this MoU upon notice in writing if:
- 2.2.2.1 The other is in breach of any Material obligation contained in this MoU, which is not remedied (if the same is capable of being remedied) within 30 days of written notice from the other Party so to do; or
- 2.2.2.2 A voluntary arrangement is approved, a bankruptcy or an administration order is made or a receiver or administrative receiver is appointed over any of the other Party's assets or an undertaking or a resolution or petition to wind up the other Party is passed or presented (other than for the purposes of amalgamation or reconstruction) or any analogous procedure in the country of incorporation of either party or if any circumstances arise which entitle the Court or a creditor to appoint a receiver, administrative receiver or administrator or to present a winding up petition or make a winding-up order in respect of the other Party.
- 2.2.3 Termination of this MoU (howsoever occasioned) shall not affect any accrued rights or liabilities of either Party nor shall it affect the coming into force or the continuance in force of any provision hereof which is expressly or by implication intended to come into or continue in force on or after such termination.

### 2.3 Relationship of the Parties

- 2.3.1 The Parties acknowledge and agree that the Services performed by CG, its employees, agents or subcontractors shall be as an independent contractor and that nothing in this MoU shall be deemed to constitute a partnership, joint venture, agency relationship or otherwise between the parties.

## 2.4 Confidentiality

2.4.1 Neither Party will use, copy, adapt, alter or part with possession of any information of the other which is disclosed or otherwise comes into its possession under or in relation to this MoU and which is of a confidential nature. ## 2.5 Miscellaneous

2.5.1 The failure of either party to enforce its rights under this MoU at any time for any period shall not be construed as a waiver of such rights.

2.5.2 If any part, term or provision of this MoU is held to be illegal or unenforceable neither the validity or enforceability of the remainder of this MoU shall be affected.

2.5.3 Neither Party shall assign or transfer all or any part of its rights under this MoU without the consent of the other Party.

2.5.4 This MoU may not be amended for any other reason without the prior written consent of both Parties.

2.5.5 This MoU constitutes the entire understanding between the Parties relating to the subject matter herewith unless any representation or warranty made about this MoU was made fraudulently and, saves as may be expressly referred to or referenced herein, supersedes all prior representations, writings, negotiations or understandings with respect hereto.

2.5.6 Neither Party shall be liable for failure to perform or delay in performing any obligation under this MoU if the failure or delay is caused by any circumstances beyond its reasonable control, including but not limited to acts of god, war, civil commotion or industrial dispute. If such delay or failure continues for at least 7 days, the Party not affected by such delay or failure shall be entitled to terminate this MoU by notice in writing to the other.

2.5.7 In the event of any dispute arising out of or in connection with this MoU, the parties will attempt in good faith to resolve such dispute through negotiations between them. Where the parties are unable to resolve a dispute by means of negotiation then all disputes, controversies or differences arising out of or in connection with this MoU shall be finally settled in the courts of Singapore.

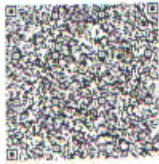

This Agreement (hereinafter called AGREEMENT) made and entered into on this **12<sup>th</sup> Feb 2021** between **Minda Corporation Limited**, Registered office address, A-15, Ashok Vihar, Phase-I, Delhi-110052, Unit details: **Spark Minda Technical Centre**, Local Address, E-5/2, Chakan Industrial Area, Phase - III, M.I.D.C, Nanckarwadi, Tal: Khed, Pune - 410501 (Hereinafter called SMIT, India) and **REVA University**, duly created as per the section 2(f) of the UGC Act, 1956, Approved by AICTE, New Delhi and existing under the laws of the India called as "RU"

SMIT and the RU are hereinafter collectively referred to as the "parties" and each individually as the "party".

## 1. OBJECTIVES OF THE AGREEMENT

The objectives of this agreement are:

- a. to facilitate a symbiotic relationship between **SMIT, Pune** and **RU** students/facilities, on projects identified for collaborative business, based on the terms and conditions as may be agreed upon for each of those identified projects
- b. to promote interaction between **SMIT** and **RU** in areas of upcoming technologies identified and consented by both the parties
- c. to provide a basis for joint collaborative work and create an environment to facilitate the same
- d. to become the most preferred and trusted partners in the area of knowledge enrichment
- e. to conceptualize research projects, to be executed in collaboration on need basis.
- f. to share information and technology to develop the required skills. To this intent, the parties shall strive to create a center of excellence to support their collaborative effort

## 2. AREAS OF COLLABORATION

The principal technical and research areas of collaboration between **SMIT** and **RU** are around the following niche areas but not limited to:

- Automotive Electronics and embedded systems
- AI and Machine Learning based secured vehicle access solutions
- Cyber security and crypto algorithms in automotive applications

Signatory authorities from both sides can mutually work out for a common consensus in case there are amendments in the areas of work in context. They will also decide the priority in aforementioned areas.

### 3. PROPOSED MODES OF COLLABORATION

Governance and Program Management committees shall monitor, approve and appoint the owners for each of the activities from either side for execution and monitoring.

SMIT and RU propose the following primary activities to collaborate:

- 3.1. Mentoring: Mentoring Engineering & Management graduates from identified Experts of SMIT
- 3.2. Incubation Center A collaborated RU and SMIT incubation center can be established at RU to nurture and guide innovation ideas of students of the final year of the institution. RU shall be responsible to provide sufficient space and resources to manage, maintain and safeguard the incubation center.
- 3.3. Capability Development: Support to Research students and faculties: Research work leading to M. TECH/PhD degree Identify the finer area of pursuit and identify the owner from each side with participants drawn from working professionals from SMIT and Faculty/Graduate/Postgraduate/PhD students from RU Cross skilling and up skilling graduate, postgraduate and PhD. students/associates and faculty members/SMEs at both SMIT and RU
- 3.4. Laboratory Development: Creating, developing the necessary laboratories and other infrastructure at both SMIT and RU
- 3.7. Sponsored Projects: Identify and execute the time-bound and tangible projects at either of the organizations especially by involving graduate/postgraduate/Ph.D. students from RU
- 3.8. Recruitment: Active graduate and post-graduate level students from selective branches of RU would be enabled to come on board subject to clearing through the natural quality gates of SMIT recruitment process
- 3.9. Publication, Product and Patent White papers: Participation in national [international conferences/journals Patent development Practice, Framework or Product development
- 3.10. Workshops, Conclave, Seminars and Events: SMIT and RU associates to jointly arrange or participate in Workshops, Conclaves, Seminars Competitions and other events at state, national and international level around the area of collaboration.

### 4. PROPOSED TIMEFRAME

While both SMIT and RU look forward to a long term, we enter into this AGREEMENT for an initial term of one (3) year and thereafter review and renew the AGREEMENT every year on mutually agreed terms between both the parties. Strategic and Governance board shall identify the necessary terms of reference for such periodic review.

## 5. IPR

Each party reserves and retains all right, title and interest in and to its proprietary software, products, and processes. The treatment of intellectual property and data rights, including patents, industrial design registration, copyrights and all other proprietary information (including innovations not patented, designs not registered etc.) which result from the research collaboration is property of both parties. Neither party shall take any action inconsistent with, nor that might adversely affect, other party's rights hereunder. Nothing contained in this AGREEMENT will be construed as granting or conferring any rights by license or otherwise, express or implied, or otherwise for any patents, copyrights, trademarks, know-how or other proprietary rights of either party acquired prior to or after the date of this AGREEMENT.

It is also mutually agreed between the parties that this AGREEMENT excludes development/creation or invention of IPR by students, faculty, and employees of either party, who has received a grant from any university, government or any other funding organization. In other words, IPRs developed by virtue of joint work done by SMIT and RU stakeholders under this AGREEMENT will be Intellectual Property" of SMIT only. Separate supporting information mentioning further insight into definitions and scope pertaining to IPR is provided in Annexure 1.

## 6. CONFIDENTIALITY

- a. During the period of this AGREEMENT and for a period of THREE years from the date of termination of this Agreement, each party agrees to consider as confidential all information disclosed by the disclosing party in written or tangible form or, if orally disclosed confirmed in writing within thirty days of disclosure and identified as confidential by the disclosing party.
- b. The obligations above shall not extend to any confidential information for which the receiving party can prove that this information is in the public domain at the time of disclosure or comes within the public domain without fault of the receiving party is already known or become known to the receiving party received from a third party having no obligations of confidentiality to the disclosing party is independently developed by the receiving party; or is required to be disclosed by law or court order.

Parties acknowledge that the confidential information is valuable and unique. In case of breach, the affected party shall be entitled to injunctive relief in addition to all other remedies available in law or equity including monetary damages. In addition to above, the stakeholders involved during this program engagement should adhere to security policies including information security of both parties. Researchers and developers must comply to information security policies.

## 7. NON-EXCLUSIVITY

The relationship of the parties under this AGREEMENT shall be non-exclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other AGREEMENTs or collaborations of any kind.

## 8. TERMS AND TERMINATION

This AGREEMENT may be amended or terminated earlier by mutual written Agreement of the parties. Either party shall have the right to terminate this AGREEMENT upon 90 days

13. Each party assumes no responsibility to the other for costs, expenses, risks, and liabilities arising from the efforts of the other.
16. ## Annexure 1: IPR

### Definitions

"Intellectual Property" (IPR) means all forms of intellectual property under the laws of any state or country including the following: (i) patents (including but not limited to industrial design patents/industrial design registration) and patent applications, together with any foreign counterparts, (ii) trademarks, brand names, trade names, business names, label marks, service marks, logos, or trade dress; (iii) copyrights, statutory or common-law, arising under the applicable laws, whether registered or unregistered and whether published or unpublished, all registrations and recordings thereof, and all applications in connection therewith, including, without limitation, all registrations, recordings and applications in any copyright authority, and the right to obtain all renewals thereof, as well as mask work rights, mask work registrations (iv) software including entire commented code along with the entire software, website, and the mobile application developed for the local servers, on individual industrial computers, mobile and central servers developed, computer programs, including any and all software implementations of algorithms, models and methodologies, whether in source code or object code, and firmware embedded in any hardware; descriptions, flow-charts and other work product used to design, plan, organize and develop any of the foregoing; (v) know-how, trade secrets including all confidential and proprietary information with respect to a specific product or process and information, including but not limited to technical information, written materials, equipment, facilities, tooling, facilities designs, product parts, processes, ideas, formulations, set of instructions either in soft or hard form including application data set, data, databases & documentation, designs, plans, and policies, programs (including source code, program codes, program summaries, program listings, program logic, programming tools, specifications, file formats, manuals, reports, operation guides, installation guides, graphic or artistic work, rights of privacy and publicity, and other forms of industrial property and other documentation or programming materials), research, process and technology developments, inventions, formulac, blue prints, confidential or secret processes, case studies, vendor lists, marketing plans, promotional materials, information relating to sales, suppliers, customers, employees, manufacturing, marketing, business plan, financial and personnel (terms of compensation, pricing structure, performance levels of employees, information of the actual or anticipated business of the entity), whether in oral, graphic or electronic form and rights associated with the foregoing; that is first conceived or reduced to practice in the performance of the project and disclosed in writing to a party.

"Sole Intellectual Property" means Intellectual Property invented, developed, created or discovered solely by employee/student/faculty of a single party.

"Joint Intellectual Property" means Intellectual Property invented, developed, created or discovered jointly by employees/students/faculties of the parties or by employees/students/faculties who are obligated to assign to the parties in performance of the project; provided that in the case of a patentable invention each such employee qualifies as an inventor pursuant to applicable patent law.

IPR covers Copyright, Patent, Trademark, Industrial Design, Database rights, Trade Secrets: This needs to be contractually covered separately.

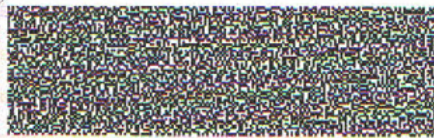



4. Publication of Intellectual properties (IPs) developed jointly through project/research collaboration.
5. Participation in seminars, colloquia, and other types of academic discussions.
6. Co-branding of the REVA wherever applicable.

### **Implementation**

The implementation of cooperation based on this Memorandum shall be dealt with between both the organizations. 

Both Parties hereby agree and upon to initiate program addressing research projects, identifying and applying for funding agencies, establishment of start-up at REVA NEST, Technology Business Incubator from 04/03/2020; whereas second party on its part proposes to address the broad area of its interest, under this memorandum, and agrees to do the following:

### 1. Aim of Partnership:

First party to provide Incubation facility to second party.

### 2. Infrastructure & other requirements from Second Party.

- First Party will provide necessary infrastructure for office affairs, R&D Space (49 x 14 feet), electricity, water and landline to the second party.
- Second Party will use other Amenities available with First Party such as parking area, Pantry/Food Court, Board Room, Conference rooms, and training rooms, if required (based on availability and nominal charges).

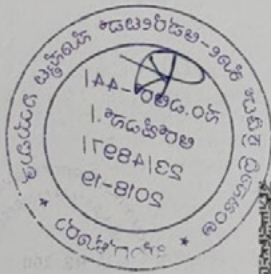

NOW, THEREFORE, pursuant to the consideration and mutual covenants and agreements set forth in this Agreement, and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties, with an intent to be legally bound, hereby agree as follows:

## **1. INTERPRETATION**

In this Agreement:

- a. The headings are used for convenience and ease of reference only and shall not affect the construction or interpretation of any provisions of this Agreement.
- b. Unless the context otherwise requires, references to the singular include a reference to the plural and vice versa, and references to any gender includes a reference to all other genders.



- c. Unless required otherwise, references to Recitals, Clauses and Schedules shall be deemed to be references to recitals, clauses and schedules of this Agreement.
- d. References to any enactment are to be construed as referring also to any amendment or re-enactment thereof (whether before or after the date of this Agreement) and to any rules, regulations or orders made under it.
- e. The expressions “hereof”, “herein”, “hereunder” and similar expressions shall be construed as references to this Agreement as a whole and not limited to the particular clause or provision in which the relevant expression appears;
- f. The words “include” and “including” will be read without limitation; and
- g. A provision of this Agreement shall not be interpreted against any Party solely on the ground that the Party was responsible for the drafting of this Agreement.

## 2. NATURE OF ALLIANCE

### 2.1 Role and Obligations of WP

2.1.1 REVA hereby engages WP for rendering the following services with effect from 30<sup>th</sup> November, 2020:

- a. WP will engage with industry to bring real world projects and expert mentors (at the cost of REVA) to work with project teams which would potentially lead to funding projects, student internships, placements and entrepreneurship with the assistance of REVA.
- b. WP will take ownership of the space design including layout drawings consisting of civil requirements, layout of machines, IT, Safety, Security, furniture requirements, on-site shop for inventory, aspects of ergonomics and the like for REVA to fulfill with their vendors and system integrators.
- c. WP will place one trained staff member at the Fablab for a period of 40 hours per week to advise and assist to create the training process and also maintain the Fablab operation process.
- d. WP will provide a 1-day intensive and hands-on training to necessary staff (identified and employed by REVA) not exceeding 5 in number on equipment management, inventory management, basic repairs and maintenance in accordance with warranty requirements etc. as necessary once per semester in the academic year for the duration of this contract.
- e. WP will help REVA to apply for Fab Lab status at the earliest and not later than January 2022.
- f. WP will provide service to boost innovation and nurture the entrepreneurship ecosystem at REVA.

- g. WP will provide necessary support, access and resources to REVA during the tenure of this Agreement that are reasonably required to improve the quality of student projects and help map student portfolios for employment, innovation and entrepreneurship.
- h. WP will connect REVA to its vendors, contacts and relations with other academic institutions, industry, research organizations and collaborators.
- i. WP will be responsible for the organization of a maximum of “two (2)” “1-day” events as listed in Appendix II every month of the working semester at the Fab Lab.
- j. For all scheduled events to be conducted on a half yearly basis as listed in Appendix II, separate budgets and procedures will be followed for approval, independent of Fab Lab operating cost.

**2.1.2** Notwithstanding anything to the contrary to the clause mentioned in point (d) of page 2, point 2.1 of page 3, REVA hereby agrees that they shall not contract or otherwise engage any service provider other than WP during the term of this Agreement for services which are to be rendered by WP hereunder.

**2.1.3** WP will Place the REVA University logo and profile on its website (<https://workbenchprojects.com/>), marketing collateral and newsletter

**2.1.4** WP will announce this partnership with RU through social media groups

**2.1.5** WP will make announcements of this partnership as well as updates of key milestones on social media groups

## **2.2 Role and Obligations of REVA**

**2.2.1** REVA will be responsible for financing the establishment and operations of the Fab Lab including the cost of license fees, insurances, security, statutory, civil, infrastructure, fit out, furniture, fittings, logistics, duties/customs, payouts, salaries, reimbursements and the like, including for costs as envisaged in this agreement, if any.

**2.2.2** REVA will provide adequate space as agreed mutually by both parties to build strategic advantage and complete benefit of the Fab Lab..

**2.2.3** REVA will finance the creation of space, installation and commissioning of machines and equipment, fabrication of furniture and establishing the on-site inventory shop.

**2.2.4** REVA will finance various activities of the engagement as per pre-approved plans, program calendar and its schedule.

**2.2.5** REVA agrees to consult with WP for the following 5 items beyond the scope of Fab Lab as necessary: a. Space Design and Installation; b. Hiring, Training and Handover; c. Program, Project & Product - Design & Execution; d. Entrepreneurship; and e. Incubation

- 2.2.6** REVA will take ownership of execution of the space through its registered vendors and system integrators as per the designs from WP, including civil, fitout, fittings, layout for machines, furniture, IT, safety, security, on-site shop for inventory stocking and issuing, aspects of ergonomics and the like.
- 2.2.7** REVA will oversee the creation of space, installation and commissioning of machines and equipment, fabrication of furniture and establishing the on-site inventory shop.
- 2.2.8** REVA will procure different machines and equipment, respective correct consumables, safety gadgets from the comprehensive list provided by WP.
- 2.2.9** REVA will be a proactive information source of industry partnerships, grants and any other funding support for Fab Lab both at the national and international level and with the support of WP to write competitive project proposals for such partnerships, grants and funding support.
- 2.2.10** REVA will support WP to create and nourish external facing engagements and also supervise internal programmes spearheaded by mentors assigned by both parties.
- 2.2.11** REVA will engage with industry to bring real world projects and expert mentors (at its own-cost) to work with project teams which would potentially lead to funding projects, student internships and placements.
- 2.2.12** REVA will provide WP complete access to the committee that oversees the activities of the FabLab and will ensure a SPOC from the committee to be nominated for efficient daily operational troubleshooting and decision making.
- 2.2.13** REVA will provide access for WP to assist placement centers and incubation centers during the tenure of this Agreement, to improve the quality of student projects and startups, to help map student portfolios for employment, innovation and entrepreneurship.
- 2.2.14** REVA will handle all the technical and FabLab procurement related tasks as per the pre-approved vendor contacts shared by WP.
- 2.2.15** REVA will place WP logo on its website (<https://reva.edu.in/>), marketing collateral and newsletter.
- 2.2.16** REVA will announce and promote this partnership with WP through social media groups.
- 2.2.17** REVA will announce and promote this partnership through the issuance of a press release.
- 2.2.18** REVA will promote Fablab operated by Workbench Projects to Reva University students and faculty.

### 2.3 Joint Responsibilities of REVA and WP

REVA and WP shall jointly:

- a. Design, Develop, Execute and implement proper operational procedures for the space including the safety norms as per international standards.
- b. Develop scope of work, program specific plans and deliverables (as per the agreed roadmap) with all cost outlines, its scheduling for procurement and installation – establishment to running costs on a yearly basis (as per the academic year and calendar).
- c. Design and develop an external and internal facing marketing plan to be executed.
- d. Design the format and to execute as per mutually agreed schedule, various activities of the space for the period of this Agreement without prejudice to the primary priorities of either Party.
- e. Develop all cost outlines, its scheduling for execution – establishment to running costs.

**4. COMMERCIALS**

4.1 In consideration for the services and responsibilities of WP set out in this Agreement, REVA agrees to pay the following consideration to WP:

\*\* This budget is to be paid by REVA to the vendors curated and selected by WP for procurement and installation. The complete list of equipment and consumables are listed in Appendix I.

4.2 REVA shall make payments within 25 days from the issuance of invoice by WP (“Due Date”).

4.3 For the phase wise activities and engagements as agreed by both the Parties (with phase wise approvals and plans) as set out in this Agreement, REVA agrees to budget for the following in its individual contracts with WP for smooth execution:

4.4 All fees, budgets and commercials are inclusive of Goods and Services Tax (GST) and other taxes and levies as may be applicable. Wherever any withholding tax is deductible as per applicable law, REVA shall deduct such withholding tax and duly provide a certificate to WP evidencing deposit thereof with the relevant governmental authority.

4.5 In case of wire transfer, the payments to be made to WP under this Agreement shall be made to the following bank account or such other bank account(s) as may be notified by WP in writing from time to time:

**5. REPRESENTATIONS AND WARRANTIES**

- 5.1 Each Party represents and warrants to the other that the execution, delivery and performance of this Agreement does not conflict with or result in a breach of or a default under any applicable law, judgment of a court/tribunal (including, without limitation, any order, injunction, decree or ruling of any court or governmental authority) and/or any agreement or instrument to which such Party is a party.
- 5.2 The Parties hereby undertake and agree not to:
- Describe themselves as an agent or representative of the other Party;
  - Pledge the credit of the other Party in any way; and/or
  - Make any representations to the customers or any third party or give any warranties, which may require the other Party to undertake or be liable for, whether directly, or indirectly, any obligation and/or responsibility to the customers or any third party.

**6. INDEMNITY**

- 6.1 Each Party shall be liable to indemnify the other Party for any loss arising from or arising out of:
- Its failure to perform any of its obligations under the Agreement;
  - Any breach of its representation and warranty set out in this Agreement;
  - Claim from any statutory authority or any employee(s) or employee(s) of subcontractors of such Party owing to non-compliance by such Party with the terms of its agreement with the employee(s) or the sub-contractor(s); and/or
  - Any negligence, fraud, forgery or dishonesty of such Party and its employees, agents and subcontractors.
- 6.2 Notwithstanding anything to the contrary, the aggregate liability of WP under this Agreement shall not exceed all amounts paid to it towards its professional fee under this Agreement.

## 7. TERM AND TERMINATION

- 7.1 This Agreement shall subsist for a period of 15 months from the date hereof, unless terminated earlier by either Party in accordance with the terms of this Agreement.
- 7.2 Either Party shall be entitled to terminate this Agreement without cause by serving a written notice of at least 60 days.
- 7.3 WP shall be entitled to suspend performance of this Agreement in case any of its payments are outstanding for 15 days beyond the Due Date.
- 7.4 WP shall be entitled to terminate this Agreement forthwith by serving a written notice on REVA in the event any of its payments are outstanding for 30 days beyond the Due Date.
- 7.5 REVA shall be entitled to terminate this Agreement forthwith by serving a written notice on WP in the event of any discrepancy in the quality of work as committed.
- 7.6 A Party shall be entitled to terminate this Agreement forthwith by serving a written notice on the other Party in the event of breach by the other Party of any applicable laws or order of any court, provided such breach is not cured within 30 days from the date of the written notice bringing such breach to the notice of the defaulting Party.

## 8. CONSEQUENCES OF TERMINATION

In the event of termination of this Agreement for any reason whatsoever or expiration of the term hereof: REVA shall stop all the next payments to WP.

REVA shall, within five (5) days thereof, at WP's option, return and/or destroy, all materials, property and information (including Confidential Information) received from WP during the course of this Agreement in whatsoever form contained in REVA's possession or control.

## 9. INTELLECTUAL PROPERTY RIGHTS

- 9.1 Background IP: This Agreement does not affect the ownership of any Party of any rights in patents, copyrights, design rights, trademarks, service marks, logos, trade secrets, know-how, database rights, geographical indications and other rights in the nature of intellectual property rights (whether registered or unregistered) and all rights in the applications for the same, anywhere in the world, (collectively, "**Intellectual Property**") that are: (i) owned by (or licensed to) such Party before the execution of this Agreement; and/or (ii) developed or otherwise acquired by such Party independently of this Agreement.

9.2 Intellectual Property created during rendering the Services: It is agreed by and between the Parties that:

- a. Intellectual Property created or developed during and in the performance of this Agreement by either Party or jointly by both the Parties, which pertains to product design, innovation, entrepreneurship and DIY research and responsible innovation shall be owned by WP, to the exclusion of REVA.
- b. Intellectual Property created or developed during and in the performance of this Agreement and arising out of the works performed by REVA alone, which pertains to anything other than product design, innovation, entrepreneurship and DIY research and responsible innovation, shall be owned by REVA, to the exclusion of WP.
- c. Intellectual Property created or developed during and in the performance of this Agreement by either Party or jointly by both the Parties, which pertains to anything other than product design, innovation, entrepreneurship and DIY research and responsible innovation, shall, at the option of WP, either be owned jointly by WP and REVA or solely by REVA.

9.3 In respect of Intellectual Property jointly owned by: (i) WP; and (ii) REVA in terms of Clause 9.2(c), the Parties shall intimate each other of creation or development of such Intellectual Property and mutually agree in writing with regard to joint protection of such Intellectual Property. If the Parties are unable to agree on seeking protection and/ or registration of such Intellectual Property created or developed, the willing Party shall have the right to seek such protection and / or registration under its name. Thereafter, such Party seeking protection/ registration of the Intellectual Property shall grant to the other Party and the other Party's customer's (where such other Party is WP) during the term of such rights and all extensions and renewals thereof, a world-wide, irrevocable, perpetual, fully paid and royalty-free license, to such rights for the said Intellectual Property. If the Parties jointly obtain protection and/ or registration of such Intellectual Property, each Party shall grant to the other Party and the other Party's customers (where such other Party is WP) during the term of such rights and all extensions and renewals thereof, a world-wide, irrevocable, perpetual, fully paid and royalty-free license, to such rights for the said Intellectual Property.

9.4 Neither Party shall file an application for patents or design rights using the other Party's Intellectual Property.

## 10. GOVERNING LAW AND DISPUTE RESOLUTION

10.1 Any problem, issue, dispute, claim etc., arising out of or in connection with this Agreement, including any question regarding their existence, validity or termination ("**Dispute**") shall be determined by a final and binding arbitration as per Arbitration and Conciliation Act, 1996 and this Clause 11.



- 10.2 The Parties shall appoint a mutually agreed single arbitrator. In case the Parties fail to mutually agree upon the appointment of a sole arbitrator within ten (10) days from the referral of disputes to arbitration, the sole arbitrator shall be appointed in accordance with the Arbitration and Conciliation Act, 1996.
- 10.3 The seat and venue of arbitration shall be Bengaluru. The language to be used in the arbitral proceedings shall be English.
- 10.4 Each Party will pay its own cost and expenses.
- 10.5 All matters relating to arbitration or any other dispute resolution process shall be maintained in confidence.
- 10.6 The Parties acknowledge that the immediate remedies at law may sometimes be inadequate, the Parties shall therefore be entitled to seek additional injunctive relief in the event of any breach of this Agreement.
- 10.7 All remedies available to either Party under this Agreement are cumulative and may be exercised concurrently or separately; the exercise of any one remedy will not be deemed an election of such remedy to the exclusion of other remedies; and the rights and remedies of the Parties as set forth in this Agreement are not exclusive and are in addition to any other rights and remedies available to it at law or in equity.
- 10.8 This Agreement shall be interpreted and governed by the laws of the Republic of India and any Disputes arising out of this Agreement shall, subject to the foregoing provisions of this Clause 11, be subject to the exclusive jurisdiction of courts of Bengaluru.

## 11. MISCELLANEOUS

### 11.1 No Poaching

During the term of this Agreement and for a period of 6 months thereafter, neither Party shall employ or engage any person who is an employee or an intern, or who was during the term of this Agreement an employee or an intern, of the other Party, without the express prior written approval of the other Party.

### 11.2 Successors and Assigns

11.2.1 The provisions of this Agreement shall be binding upon and inure to the benefit of the Parties hereto and their respective successors and permitted assigns.

11.2.2 The Parties hereto may not assign this Agreement and/or any rights and/or obligations hereunder without the prior written consent of the other Party, which consent shall not be unreasonably withheld. Any assignment in contravention of this provision shall be void.

### 11.3 Entire Understanding

This Agreement constitutes the entire understanding between the parties with respect to the subject matter hereof and supersedes all prior written agreements, understandings and negotiations, both written and oral, between the Parties with respect to the subject matter of this Agreement. No representation, inducement, promises, understanding, condition or warranty not set forth herein has been made or relied upon by any Party hereto.

### 11.4 Confidentiality

The Parties shall keep confidential all information received by the Parties pursuant to this Agreement until the expiry of two years from the termination of this Agreement. The Parties will maintain the utmost confidentiality regarding the contents of this Agreement at all times and none of the Parties will make any announcement to the public or to any third party regarding the arrangements contemplated by this Agreement without the consent of the other, which consent shall only be in writing and not be unreasonably withheld or delayed.

The receiving Party shall not be liable for disclosure or use of any confidential information:

- a. If the same is in or enters the public domain without in any manner attributable to the acts and/or omissions of the receiving Party;
- b. If the same is known to the receiving Party at the time of first receipt, or thereafter becomes known to the receiving Party prior to such disclosure without similar restrictions from a source other than the disclosing Party, as evidenced by written records; or
- c. If such disclosure is required by law, or called for by the requirements of any statutory and/or any other regulatory authority, provided such disclosure shall be no more extensive than is usual or necessary to meet the requirements imposed upon the Party making such statement or disclosure.

### 11.5 Amendments; No Waivers

11.5.1 No amendment or change to the Agreement or any waiver or discharge or any rights or obligations under the Agreement will be valid unless in writing and signed by both the Parties.

11.5.2 Any delay or omission by either Party to exercise any right or power under the Agreement will not be construed to be a waiver thereof by such Party. A waiver by either Party of any of the covenants to be performed by the other or any breach thereof will not be construed to be a waiver of any succeeding breach thereof or of any other covenant in this Agreement.

**11.6 Severability**

In the event that any provision of the Agreement conflicts with the law under which the Agreement is to be construed or if any such provision is held void, illegal, unenforceable or invalid by a competent authority, such provision will be deemed to be restated to reflect as nearly as possible the original intentions of the Parties in accordance with applicable law. The remainder of the Agreement will remain in full force and effect.

**11.7 Survival**

Clauses 4.4, 7 (*Indemnity*), 9 (*Consequences of Termination*), 10 (*Intellectual Property Rights*), 11 (*Governing Law and Dispute Resolution*), 12 (except Clauses 12.4 and 12.12), shall survive expiry/termination of this Agreement.

**11.8 Notices**

All notices, requests, demands and determinations under this Agreement other than routine operational communications, will be in writing through hand delivery, speed post or recognized courier service with a reliable system for tracking delivery, or through electronic mail with a copy sent by another means specified herein, to the following address:

Either Party may change its address by notifying the other party about the change in the same manner as is provided in this Clause, at least 7 days before such change is affected.

**11.9 Counterparts**

The Agreement may be executed in several counterparts, each of which, when executed by one or more Parties hereto, shall constitute an original document but all of which taken together will constitute one single Agreement between the Parties. Facsimile transmitted counterparts and PDF transmitted counterparts, which are each followed by written confirmatory originals, shall be deemed binding on the Parties.

#### 11.10 Mutual Assistance

In the event that any proceedings are initiated by a third party against a Party to this Agreement (the “**Party proceeded against**”) in relation to the services or transactions envisaged herein, the other Party shall provide all possible assistance to the Party proceeded against to defend itself in such proceedings, provided that nothing in this clause shall be construed as requiring the other Party to do any act which would prejudice its rights in any legal proceedings.

#### 11.11 Force Majeure

11.11.1 Neither Party shall be liable for any failure to perform any of its obligations under this Agreement if the performance is prevented, hindered or delayed by a Force Majeure Event (*defined below*) and in such case its obligations shall be suspended for so long as the Force Majeure Event continues. The Party affected by Force Majeure Event shall promptly inform the other of the existence of a Force Majeure Event and shall consult the other to find a mutually acceptable solution.

11.11.2 “**Force Majeure Event**” means any event beyond the reasonable control of the affected Party including, without limitation, unavailability of any communication system including internet, breach or virus in the processes or payment mechanism, sabotage, fire, flood, explosion, acts of God, civil commotion, strikes or industrial action of any kind, riots, insurrection, war, acts of government, computer hacking, unauthorized access to computer data and storage devices, computer crashes, breach of security and encryption codes.

#### 11.11.3 Relationship

This Agreement is executed on principal to principal basis. WP shall provide any services hereunder as an independent service provider. Nothing in this Agreement will be deemed or construed to create a joint venture, agency, or partnership between the Parties for any purpose or between the partners, officers, members, or employees of the Parties by virtue of either this Agreement or actions taken pursuant to this Agreement.







It runs various programs to take a multipronged approach to development through technology - gives a platform for visibility to the NGOs and social impact organizations, helps companies to learn and implement CSR projects, a Social innovation forum, hereinafter referred to as "NF" (which term shall so far as the context admits be deemed to mean and include its successors, administrators, executors and assignees) of the First Part.

AND

REVA Aspiring Youth Foundation located at Yelahanka, Bangalore, Karnataka (India) hereinafter referred to as "REVA NEST" or "the University" (which term shall so far as the context admits be deemed to mean and include its successors and assignees) of the Second Part,

NF and "REVA NEST" are collectively referred to as the "Parties" and individually as a "Party".

WHEREAS, NASSCOM Foundation has agreed to partner with "REVA NEST", for the conduct of the Cisco thingQbator program ("thingQbator") at the University (project details as per annexure 1). Cisco thingQbator is a Cisco funded program for skill and entrepreneurship development of young people in India under its CSR Mandate and implemented by the NASSCOM Foundation through its authorised partners.

AND WHEREAS this is a non-financial MOU and both the parties shall incur their part of expenses for the roles and responsibilities as enumerated on their part elsewhere in the MOU. Both the parties shall not be liable to the other party for any reimbursement of expenses. NASSCOM Foundation is funding the program costs based on the CSR grants received from CISCO whereas University shall be responsible to cater to its own budget of expenses.

NOW IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:


1. Introduction

thingQbator is a CISCO funded program for the skill development of young people in India under its CSR Mandate and the expectations are that thingQbator will help the beneficiaries also develop their entrepreneurship skills. The program will be implemented by NASSCOM Foundation.

2. The University Responsibilities:

- 2.1. Shall nominate /Identify executive sponsor, Director/ HoD, as the SPOC, with adequate accountability and responsibility to be the executive face of the program in the university. This person must participate in monthly review calls with NF for updates and assessments of the program. This person shall ideally be a member of the university faculty.

2.2. Shall coordinate with students across the university during the early days of the program to:

- Form a student body from university students already involved in robotics clubs, hackathon(fest & event) organization teams, E-Cell etc.
- Work with student body to conduct program outreach activities through word of mouth, classroom announcements and WhatsApp forwards.
- Work with faculty and university administration to create activation through official mail blasts, Website announcements and Official Social Media channels.

Student body will take care of the following activities in the program:

- **Evangelism/ Outreach** - Going out and talking about the space, bringing people in, conducting workshops outside in the community
  - **Communication** - Sharing with the world what is happening in the space
  - **Event Management** - Planning & Coordinating in-person & Virtual Events with the MMs such as Technical Workshops, Design Thinking & Ideation Sessions, Hackathons, Hackdays and Peer Demo Days
  - **Inventory Management** - Continuously Document Materials provided to Cohort Members, Updating Delivery of new items, Collating Local Purchase Requirements for MMs
  - **Impact Reporting** - Collecting & Uploading info needed like footfall, photos, milestones, outreach etc
  - **Debugging** - Helping local makers find solutions to day to day tech problems
  - **Keyholding** - Responsible for keeping the space open and accessible
  - **Partner Relations** - Sharing info and Confering with the University
  - **Treasury** - Handling money and Reporting Expenses/Revenue
  - **Fundraising** - Raise funds for projects, events, competitions
- 2.3. Shall allocate a full time Lab Admin to help manage makerspace operations such as makerspace access, attendance, equipment inventory and takes care of day to day operations along with the Makerspace Manager. The JD for the Lab Admin is in annexure-III. The salary of the Lab Admin shall be paid by the University.
- 2.4. Shall support in publicity of the Program through the University website.
- 2.5. Shall encourage the Program in a manner so that students selected for the Program will take part in the program on a voluntary basis with flexible timings.
- 2.6. Shall make available the infrastructure and value added services (including IT infrastructure, applications and connectivity) required to run the Program on its own cost. The details of such infrastructure to be provided is detailed at Annexure II to this MOU.
- 2.7. Shall provide all the support services and facilities to NF and its Partners during the conduct of the said Program. NASSCOM Foundation shall coordinate and facilitate the conduct of events and other engagement programs as per shared plan.
- 2.8. Provide lodging, wherever required to NF and its Partners during the course of the MOU period as per reasonable standards. (The lodging so planned to be provided should be with independent room (with attached toilet), regular water supply, clean, with access to boarding facilities, should have well lit approach and surroundings, have adequate safety & protection and peaceful environment.)

- 3.1. Ensure the set up the virtual thingQbator space in the space provided in the University in accordance with the description in (Annexure I)
- 3.2. NASSCOM Foundation will implement the program and will be in direct liaison with the Makerspace manager and lab admin.
  - NASSCOM Foundation will appoint the above mentioned Makerspace Manager.
  - University's single point of contact (SPOC) will be in direct liaison with NF, Cisco and its partners and broader ecosystem for program operations and ecosystem development.
- 3.3. Will be responsible for the overall execution of the program along the lines described in Annexure I and also for collecting and collating program related data from the University for submission to Cisco.
- 3.4. Run the Cisco thingQbator virtual makerspace and manage the program for the year. This would include
  - Operate program for the year,
  - Running the makerspace over 1 year
  - Running training programs to acquaint participants with IoT technologies
  - Together with the university counterpart - organize events, demo days, tech talks, and hackathons
  - Perform knowledge transfer to train university personnel for ongoing sustainable operations
  - Identify themes for targeted innovation with inputs from our government partners and experts
- 3.5. Will enrol students into the program after the due selection
- 3.6. Will conduct training programs and hands on workshops for participating students over the course of the program
- 3.7. Will setup a Student Body who will take up makerspace operations of the program
- 3.8. Will conduct regular meetings with SPOC and Cisco and partners – physical and telephonic for governance and project updates.
- 3.9. Will keep the university informed of any changes in the program plan
4. **Other Terms & Conditions for Engagement**  
The following are other terms and conditions of engagement:
  - 4.1. NASSCOM Foundation signs a MOU with the partner university, connecting it to the E-cell or the Incubation center of that University.

- Awareness campaigns are launched for students of that university about the program and interested students apply to the program through an idea submission portal.
- A competent jury set up by NASSCOM Foundation reviews the ideas submitted by students from all partner universities.
- Best 150 ideas across all universities are selected and given a place in the cohort for mentoring.
- Students will work on their technology & business plan and present it via a peer review where the top 75 teams are selected by NF through a process of stack ranking.

4.2. Cohort teams or students owning the selected ideas have access to:

- Series of live workshops and webinars to learn new technology, resolve their problems and enable their progress in their projects.
- Hard touch mentoring via WebEx video conferencing and collaboration tool
  - Maker Experts from NASSCOM Foundation for regular guidance & catch up
  - High Quality Industry Experts for domain specific requirements
  - Access to Cisco engineers and executives as mentors
- Provision of lab-type space for project work
- Access to Cloud Hosting Services and IoT hardware (Sensors, Transceivers etc)
- Prototype Manufacturing Services (PCBA, 3D Printing etc)

4.3. At the end of the program, top 10 teams are selected through a process of stack ranking, elimination and demo days.

4.4. The selected teams are provided financial support and connected with an Incubation center recognised by the Government to continue their journey towards becoming a start-up.

4.5. The final decision on the selection of candidates to be admitted in the cohort shall lie with NASSCOM Foundation.

4.6. Eliminations: Students who show a lack of interest, engagement or progress in the program would be eliminated from the cohort on a monthly basis and replaced by others who will be selected at NASSCOM Foundation's discretion.

4.7. Terms of engagement: This MoU is valid from 1<sup>st</sup> of December 2020 to 30<sup>th</sup> November 2021, however both parties agree that based on mutual agreement, the terms may be extended. Both parties also agree that terms may be renegotiated.

4.8. Training Fees: The University, NF and Partners will not charge any amount on whatsoever account/name from the students in relation to the Program

4.9. Limitations and Warranties: Both parties agree that it would be their endeavour to prevent any liability arising out of default or non-compliance of the MoU terms by the other party.

4.10. Termination: In case the parties to this MoU commit any breach of the terms and conditions of this MoU or violates any statutory provisions or any Government or statutory guidelines or any guidelines issued by the controlling authority, then, in addition to any other remedy available as per law, the other parties shall have the right to terminate this agreement by serving at least 15 days' written notice to the other parties. However, on such termination, all the parties shall continue to be liable to each other for completion of their mutual rights and obligations under this MoU, which were there on the date of the termination of this agreement. Both parties in the MoU reserve the right to terminate the MoU with one-month prior notice if in their opinion the project is not being implemented as per the MoU or the specific aims.

- 5.4. **Severability:** If any section or paragraph, or part thereof, of this MOU or any document appended hereto or made a part hereof is rendered invalid, ruled illegal by any court of competent jurisdiction, or unenforceable under present or future laws effective during the term of this MOU, then it is the intention of the Parties that the remainder of the MOU, or any document appended hereto or made a part hereof, shall not be affected thereby unless the deletion of such provision shall cause this MOU to become materially adverse to any Party in which case the Parties shall negotiate in good faith such changes to the MOU, or enter into suitable amendatory or supplementary MOUs, as will best preserve for the Parties the benefits and obligations under such provision.

**3.0 General Provisions**

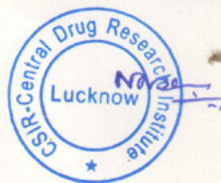
The Parties agree to cooperate and support each other for implementing this MoU effectively through the following:

- vi. The parties shall consult each other for any publication in respect of research work. These publications (papers, reports etc.) shall be in the names of actual research workers wherein it will be duly acknowledged that the work has been carried out under the collaborative research program of CSIR-CDRI and RU. As a part of collaboration, the outcomes of the research under this MoU shall develop joint publication.
- vii. Any publication, document and/or paper arising out of joint work conducted by the participants pursuant to this MoU will be jointly owned. The use of the name, logo and/or official emblem of the participants on any publication, document and/or paper will require prior permission of both the participants. It may however be ensured that the official emblem and logo are not misused.
- viii. Applications for joint Patents will be filed in the name of institutions namely CSIR and RU, Bangalore.
- ix. Both parties agree to ensure appropriate protection of Intellectual Property Rights generated from such cooperation consistent with their respective laws, rules and regulations.
- x. In case research is carried out solely and separately by a Party or the research results are obtained through the sole and separate effort of a Party, the Party concerned alone will apply for grant of IPR and once granted the IPR will be solely owned by the concerned Party.
- xi. In case of research results obtained through joint activities, the grant of intellectual property rights will be sought by both the parties jointly and once granted these rights will jointly owned by the parties on mutually agreed terms and conditions.
- xii. - xv. Once the product generated under the PROJECT is licensed to any industry(ies), CSIR-CDRI & RU shall ensure that the licensed company shall affix in a conspicuous manner upon every Finished Product and/or mode of packaging containing the Finished Product a label or plate bearing the inscription "A joint product by CSIR-CDRI & RU " in letters of size not less than half the nominal size of the largest size of letters giving either the name of the company or its brand name or trademark for the Finished Product along with the logo of CSIR-CDRI & RU. The licensed company(ies) shall not sell Finished Product and/or any box or package containing the Finished Product without such label or plate being affixed thereon and shall also abide by the guidelines of other countries for the appropriate visibility of CSIR-CDRI & RU. - xvii. Nothing contained herein shall constitute this a partnership or joint venture agreement or constitute either party as the partner, principal or agent of the other, this being a MoU between independent contracting entities.
- xviii. No amendment or modification of this MoU shall be valid unless the same is made in writing by all the parties or their authorized representatives and specifically stating the same to be an amendment of this MoU. The modifications shall be effective from the date on which they are made, unless otherwise agreed to.
- xix. Both parties shall do their utmost to ensure the smooth and efficient implementation of the program.
- xx. The parties will use their best efforts to settle all matters in dispute amicably. All disputes and differences of any kind related to this MoU shall be jointly settled between Director, CSIR-CDRI and Vice Chancellor, RU.
