They are running five year BA LLB and five year BBA LLB courses as the approval is the academic year 2016-2017. The request of the university is from the session 2018-2019 for the said two courses be converted into honours courses i.e. five year BA LL.B (Hons.) course and five year BBA LL.B (Hons.) course.

Since, these are the old courses of the University, the approval is granted for 2017-2018.

For the academic session 2018-2019, since University Wants to convert the said courses in the honours courses, the Committee has no objection and approved the same. 




